**Purpose:** An opportunity to build relationships and share knowledge and information in

support of rural transport initiatives and projects in the Waikato region.

## **Meeting notes:**

1. Welcome and Introductions: Sarah Gibb, opened with Karakia followed by acknowledgements for Volunteer Week and a round of introductions from both in-person and online attendees, including community transport providers, regional councils, and health and social service organisations.



### 2. Updates from March Symposium:

- The March symposium was highlighted as a success, with over 80 attendees and valuable outputs, including graphic recordings, which are now available online Symposiums | Waikato Community Transport Forum [CT Symposium 2025 (https://www.waikatocommunitytransport.org.nz/assets/Community-Transport-Forum/CTSymposium2025.pdf)]. The purpose of establishing these visuals is to encourage for use in funding applications and community engagement to promote a shared national vision for community transport.
- The symposium provided a valuable opportunity for in-depth discussions, covering topics such as economic scale and potential community partnerships brokering relationships.

#### 3. Partnership Case Study - Te Kūiti and 4 H Trust: Sarah Gibb and Desiree Brown

- A presentation on 'What can success look like' and a detailed case study showcased the long-standing partnership between Te Kūiti Community House and the 4 H Trust. This partnership formalises administrative and coordination support through a service agreement, demonstrating a sustainable and replicable model for community transport delivery.
- The 4 H Trust has prioritized facilitating health appointments by integrating a coordinator role within the Community House to ensure effective support for community housing needs.
- Desiree Brown, as a Trustee, has taken on key responsibilities, including funding education, accountability, booking, rosters, and coordination. A formal service agreement has been established to recognize and support volunteers, ensuring they feel valued in their roles.
- Sarah Gibb encouraged the development of such partnerships and the exploration
  of direct collaborations, emphasizing the importance of shared responsibilities in
  these initiatives. Additionally, the service agreement can be shared, offering
  insights into organizational structures, funding strategies, and potential partnership
  models for stakeholders.

### Other Partnership Examples

Participants shared additional examples of successful collaborations, including shared office space in Huntly, council partnerships in Nelson, and booking support through i-SITE, all of which help reduce administrative burden and increase community visibility.



## 4. WRC Community Transport Update: Amantha Bowen

- Community Transport Fund The regional fund has increased to \$500,000 and this had been approved and finalised, with the next round expected in November 2025. A policy review is underway to ensure the application process is fit for purpose and aligned with varying financial year cycles.
- Legal and Policy Review A comprehensive legal review of community transport
  operations is being conducted to address potential criticisms, clarify compliance
  and governance responsibilities, and guide future policy and funding decisions. The
  findings will be presented to the committee and council in September, with
  outcomes shared with all providers.
- MSD Employment Role Funding: Amantha is currently exploring this funding and will provide updates as soon as more information is available.
- Transport Review & NTA Developments: An NTA manager role has been created, though an appointment is still pending. Improvements in this area are being awaited.
- Passenger Use Survey: A new passenger survey is being developed to gather data
  on transport usage and unmet needs. The survey will be available in both print and
  digital formats and aims to support advocacy and service planning.

#### 5. Anything else: Open to the Forum

- National Travel Assistance (NTA) Discussion: Concerns were raised about inconsistencies in NTA eligibility and access, particularly for patients just under the 50km threshold. The forum discussed the need for national consistency and better communication from Te Whatu Ora.
- Risk and Volunteer Management: Participants discussed the growing complexity
  of client needs and the strain on volunteers, especially when transporting clients
  with mobility or cognitive challenges. Emphasis was placed on the importance of
  clear policies, caregiver requirements, and shared responsibility through
  partnerships.
- **Data Collection:** For those seeking funding, data plays a critical role—tracking travel frequency is essential. A voluntary survey is available, which, if completed, can help demonstrate CT's value and be utilized by WRC and stakeholders.
- Website and Resources: The Waikato Community Transport website was promoted as a central hub for resources, templates, funding information, and provider directories. Attendees were encouraged to use and share the site to increase awareness and support.



- **Forum Support:** Amantha encouraged providers to reach out regarding any issues arising from this forum so they can be supported accordingly.
